

#### **Existing Legislation:**

The Code on Wages, 2019, provides for universal minimum wage and floor wage across organised and unorganised sectors, including gig workers

The Code on Social Security, 2020, recognises gig workers as a new occupational category.

It defines a gig worker as a person who performs work or participates in work arrangement and earns from such activities, outside of the traditional employer-employee relationship.

- His philosophy was based on the principles of Ariw (true knowledge), ethos (right conduct), and Anubhava (divine experience), which brought about a social, religious, and economic revolution in the 12th century.
- He spread social awareness through his poetry, popularly known as Vachanaas.)

## What is LockBit ransomware and how is it specifically targeting Apple computers?

- LockBit ransomware was first reported in 2019. It has been dubbed as the "abcd" virus due to the file extension used when encrypting victims' files.
- It is designed to infiltrate victims' systems and encrypt important files. The virus is categorized as a "crypto virus" due to its requests for payment in cryptocurrency to decrypt files on the victim's device.
- The ransomware is therefore typically deployed against victims who feel hindered enough by the disruption to pay heavy sums in exchange for access to the files and can afford to do so.
